- MINDFUL of the Constitution;
- MINDFUL of Law No. 90/55 of 19/12/1990 based on the regime of public meetings/manifestations;
- MINDFUL of Decree No. 2008/376 of 12/11/2008 bearing on the Administrative Organisation of the Republic of Cameroon;
- MINDFUL of Decree No. 2008/377 of 12/11/2008 defining the powers and duties of Heads of Administrative Units and the Organisation and functioning of their services;
- MINDFUL of Decree No. 2005/104 of 13/04/2005 organising the Ministry of Territorial Administration and Decentralization;
- MINDFUL of Decree No. 2013/113 of 22/04/2013 appointing Mr. KOMBE Henry PASANG, Administrative Officer, Divisional Officer for Nguti Sub Division;
- CONSIDERING the repetitive organising/holding of public meetings/manifestations in Nguti Sub Division by Nature Cameroon not authorised by the Administration and in violation of the above mentioned law;
- CONSIDERING the need to maintain peace, law and order in Nguti Sub Division;

HEREBY DECIDES AS FOLLOWS:

- Section I/- That with effect from date of signature of this Decision, the organising/holding of any public meeting/manifestation by the above mentioned association is hereby suspended in Nguti Sub Division.
- Section II/- That any contravention to this Decision by the concerned shall be severely sanctioned by the law in force.
- Section III/- That the Judicial Police in Nguti and the Commander of Gendarmerie Brigade in Nguti are charged with the strict implementation and follow up of this Decision.
